# **NEW PROCESS - EFFECTIVE JULY 16, 2025**

- Candidates can cancel and reschedule an examination until 10 calendar days before the examination date.
- The cancellation or rescheduling time period does not include the event date.
- 10 calendar days before the examination date:
  - o A test event will be cancelled if the minimum number of Candidate registrations is not met.
  - o If the minimum number of Candidate registrations is met, then scheduling remains open and Candidates can register until 2 calendar days before the examination date.

EXAMPLE #1 - Candidate CANNOT Reschedule Examination	
Today's Date	7/16/2025
Candidate Examination Date	7/22/2025
Can Candidate Reschedule Their Exam?	No, Candidate can only reschedule their exam at least 10
	calendar days before the exam date.

EXAMPLE #2 - Candidate CAN Reschedule Examination	
Today's Date	7/16/2025
Candidate Examination Date	8/1/2025
Can Candidate Reschedule Their Exam?	Yes, Candidate can reschedule their exam until July 21,
	2025.
Can Candidate Reschedule to Take the	Yes, the earliest date the Candidate can reschedule to take
Exam 2 Calendar Days From Today's	the exam is July 19, 2025.
Date?	

# **CANDIDATE HANDBOOK UPDATE**

Candidate handbooks have been updated to reflect changes made by the NC Division of Motor Vehicles (NCDMV).

Per Senate Bill 391, Class C licenses (standard passenger vehicle licenses) expiring on or after July 1, 2025, will be accepted for two years beyond the printed expiration date. The NCDMV will allow this process until December 31, 2027. This does not apply to commercial driver licenses, or any licenses that are suspended, revoked, or cancelled.
